



## TRUST DEED

This Deed of Declaration of Public Charitable (Fust is executed on 10th day of April 2001 by Shri Tedinder Pall Singh Sandhu s/o Shri Jagdev Singh Sandhu r/o 33/2 Chattakpura Street, Adalat Bazar Patiala (hereinafter called the author of the trust).

WHEREAS,I the said Tejinder Pal Singh Sandhu have already set apart a sum of Rs 1,00,000 /(Rupees one lac only.) towards constituting a Public Charitable Trust and handed over the same to the trustees hereinafter appearing:

AND WHEREAS the trustees have also given consent to act as trustees and accepted the trust fund as stated above.

AND WHEREAS it has become necessary to declare the objects and terms of the Public Charitable Trust.

NOW THIS DEED OF DECLARATION of the Public Charitable Trust WITNESSESS as under:

- 1. The Name of the trust shall be \( \sigma\_\circ\) Jasdev Singh Sandhu Foundation."
- 2. The Headquarter of the trust shall be at Patiala. The office of the trust may be at any other place as the trustees may decide from time to time.
- 3. The objects of the trust are as under:
- (1) To open, run, acquire, continue and maintain Educational and Vocational institutions on Information Technology, Medical, Engineering, Computer, Management Sciences, Commerce, Arts or in any other field of Education as the trustees may decide from time to time.

- maintain open, run, acquire, continue (4)To including science dispensary,clinic,Hospital o f any Homoeopathic, Ayurvedic, Dental and Allopathic where all types of research, nursing, rehabilitation and treatment can be undertaken.
- (5)To do all acts including development of institutions which lead to upliftment of poor, needy and disabled persons and to education, food, clothing and medical facilities for them. To do all necessary acts for upliftment of villages and such acts which gives relief to the poor.
- To do all such acts which lead to promotion of art, culture and History.
- (7) To make research for the promotion of Agriculture, and produce, specially in relation to technology of seeds, floriculture and other related matters.
- (8)To accept donation, grants, presents and other offerings to deal with the same for the purpose of the trust
- (9)To donate to similar institutions having similar objects er to any other public charitable trust or to any institution for objects of Public utility.
- (10)To charge moderate and reasonable charges and otherwise themselves for the outlay and expenses incurred in the running, upkeep and maintenance of institutions to be established under this deed.
- (7) To bring out, encourage and develop the inventive and research faculties of the pupils and teachers and to afford oppurtunity for research work in education, agriculture, medical, art and other fields.
- (8) To do any act for accomplishment of the objects of the trust.

  - a) S.Tejinder Pal Singh S/o S Jasdev Singh Sandhu r/o 33/2 Chattakpura street, Adalat Bazar. Patiala.
  - b) Smt.Anupinder Kaur w/o S.Tejinder Pal Singh Sandhu r/o 33/2 Chattakpura street,Adalat Bazar.Patiala
  - c) Shri Muninder Kumar s/o Shri Gouri Shankar r/o 27/2 Chattakpura Street, Patiala.

- 5.S.Tejinder Pal Singh Sandhu is hereby nominated as Chairman of the trust.Smt Anupinder Kaur is nominated as Secretary of the trust.
- 6. The Trustees namely S Tejinder Pal Singh Sandhu and Anupinder Kaur shall hold office for life or untill they resign there from. The other trustees or additional trustees appointed/co-opted in future shall hold office for fixed term one year.
- 7. Rules may be framed for the proper administration of the trust but such rules shall not be against the objects of the trust.
- 8. The Bank Account of the Trust shall be operated by the Chairman S. Tejinder Pal Singh Sandhu and Smt Anupinder Kaup Secretary individually.
- ondividually.

  9. For the removal of doubts its hereby declared that this trust, its objects and its implementation shall not be for the benefit of any particular caste or religious community as such.
- acquire by way of purchase or lease and/or construct immovable or movable properties for the trust and likewise the power to sell, lease or mortgage or oterwise deal with such properties.
- 11. The Board of Trustees shall meet as often as may be necessary or convenient to transact business and there should be atleast one meeting in a quarter. The quroum of the meeting shall minimum two trustee. The Chairman of the trust shall preside over the meetings of the trusteea. The Board of Trustees might transact business and take decisions also by circulation of papers.
- 12. All decisions of the Board of Trustees shall be taken unanimously or by majority. The Chairman shall have a casting vote.
- 13.Without prejudice the powers of the Board of Chairman and the Secretary shall manage and administer the affairs of the trust and shall also exercise such power function as may be delegated to them by the Board of Trustees.
- 14. The liability of the trust and the trustees shall be to the property of the trust.
- 15. Proper accounts for the trust shall be kept at the office of the trust and shall be audited annually by M/s Navdeep Singh & Co Chartered Accountants Lehal Road Patiala or as decided by trustees from time to time .

16.The Trust fund may be augmented by the income from the initial fund and also by donations and other contributions from time to time.

- 17. The funds of the trust shall not be applied for any purpose other than the objects of the trust.
- 18. The surplus funds of the trust shall be invested in Bank Deposits, Government bonds or such other appropriate security or in any manner decided by the trustees from time to time.
- 19. The Board shall have power to borrow monies and also to mortgage the property of the trust to fulfill the objects of the trust.
- 20. The Trustees shall have power to accept donations in money or otherwise for the purposes of this trust.
- 23. The Trustee shall have power to appoint personnel to organise and promote the objects of the trust and to regulate their conditions of service, including matters of discipline.
- 24. All acts and proceedings of the trust shall be taken and conducted in the name of the trust.

25.Each trustees who are appointed for life shall nominate or appoint a successor to him either through will of otherwise. The legal successor/nominated person shall be deemed to have, become trustee from the date of death and their term shall also bromain for life. The Board of Trustees have also power to appoint any number of trustees.

26 . The trust is irrevocable.




